

BUDGET RESOLUTION 2020-197

A RESOLUTION TO ADOPT A BUDGET FOR THE CITY OF OCALA FOR FISCAL YEAR 2020-2021 IN THE AMOUNT OF \$817,129,466

WHEREAS, the City Council reviewed the proposed budget during a public workshop on August 25, 2020; and

WHEREAS, a public hearing was held on September 15, 2020 to adopt a tentative budget in accordance with Florida Statutes, Section 200.065.

WHEREAS, the required notice of tax increase and budget advertisements were published on September 18, 2020, and a public hearing to adopt the final millage and budget was held on September 22, 2020.

WHEREAS, this resolution includes the budgets for the Redevelopment Subarea Funds that were recommended by the Community Redevelopment Agency Advisory Board and the Downtown Development Fund previously adopted by City Council.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF OCALA, FLORIDA, duly assembled that the annual budget of \$817,129,466 for the City of Ocala for the period beginning October 1, 2020 through September 30, 2021, is hereby adopted as follows:
