

BUDGET RESOLUTION 2021-142

A RESOLUTION AMENDING THE FISCAL YEAR 2020-2021 BUDGET TO ACCEPT AND APPROPRIATE FUNDS FROM THE FLORIDA DIVISION OF EMERGENCY MANAGEMENT AND THE FEDERAL EMERGENCY MANAGEMENT AGENCY FOR GENERATORS AND UTILITY PROTECTION FOR THE SANITARY SYSTEM IN THE AMOUNT OF \$1,454,257 AND TO TRANSFER MATCHING FUNDS FROM THE WATER RESERVE FOR CONTINGENCIES ACCOUNT IN THE AMOUNT OF \$484,752 FOR AN ESTIMATED PROJECT COST OF \$1,939,009

WHEREAS, the City has been awarded a grant through the Hazard Mitigation Grant Program DR-4337-424-R, as approved by the Florida Division of Emergency Management and the Federal Emergency Management Agency for Generators and Utility Protection for the Sanitary System; and

WHEREAS, this grant addresses the installation of generators at twenty lift stations and manhole covers and seals replacement, which includes surveying, engineering, design, plans preparation, permitting and bidding for the proposed project; and

WHEREAS, this project will protect the sanitary sewer system against any storm and flooding event; and

WHEREAS, the Florida Division of Emergency Management and the Federal Emergency Management Agency will fund an amount not to exceed \$1,454,257 and the City will provide a match of \$484,752 which will be taken from the Water Reserve for Contingencies.

NOW, THEREFORE, BE IT RESOLVED THAT THE CITY COUNCIL OF THE CITY OF OCALA, FLORIDA, duly assembled in regular session that the FY2021 budget be amended to accept and appropriate grant funding from the Florida Division of Emergency Management and the Federal Emergency Management Agency as outlined below:
