A RESOLUTION AMENDING THE FISCAL YEAR 2020-2021 BUDGET TO ACCEPT AND APPROPRIATE FUNDS FROM THE NORTHEAST FLORIDA REGIONAL COUNCIL FOR THE PURCHASE OF COLLECTION POINT DROP BAG SUPPLIES IN THE AMOUNT OF \$5,000

BACKGROUND:

The Northeast Florida Regional Council (NEFRC) has partnered with the Coalition for Health and Medical Preparedness Program to purchase Collection Point Drop Bag Supplies. This program is to provide a variety of equipment that could be used for mass casualty events.

Ocala Fire Rescue (OFR) applied for and was awarded the grant from the Northeast Florida Regional Council for the purchase of collection point drop bag supplies.

This equipment will enhance the effective care and delivery of patients in addition to supplies for a large scale event.

This grant provides Ocala Fire Rescue (OFR) the opportunity to purchase collection point drop bag supplies that will greatly assist in the event of mass casualty incident.

FINDINGS AND CONCLUSIONS:

- OFR was awarded a grant from the Northeast Florida Regional Council in the amount of \$5,000
- The grant will allow OFR to purchase equipment in the event of a mass casualty
- Acceptance of the grant will provide the opportunity to purchase supplies and equipment for collection point drop bag supplies that would be beneficial in the event of a mass casualty.
