



STAFF RECOMMENDATION (Motion Ready): Adopt Budget Resolution 2021-159 amending the Fiscal Year 2020-2021 budget to appropriate grant funding from the Federal Aviation Administration for the sealing of runway pavement and joints in the amount of \$298,971

BACKGROUND:

Airport staff is working with Federal Aviation Administration (FAA) officials to perform pavement maintenance (crack sealing and seal coating) of Ocala Airport's main runway. Since the latest pavement overlay in 2009, transverse cracks along the shoulders have worked through that pavement.

Additionally, the pavement mix included a high concentration of iron oxides, which when combined with water have created a rusting effect that accelerates discoloration of the white runway paint, effectively turning it yellow. The grant funds will be used for crack repair and application of a seal coat, providing new oils to the pavement and sealing it, thereby reducing the rusting effect on the paint.

The City received a FAA grant in the amount of \$298,971 in July 2021 for sealing of runway pavement and joints in the amount of \$298,971.

FINDINGS AND CONCLUSIONS:

Construction will occur in phases to minimize disruption to the normal air traffic activity. The Airport Advisory Board supports the project.
