





BACKGROUND:

On 08/31/2021, the Ocala Police Department was advised that the application submitted by the City of Ocala for the 2020 Justice Assistance Grant - County-wide (JAGC) was approved in the amount of \$26,132 to aid with the purchase of equipment for the OPD Community Outreach program.

The subgrant award in the amount of \$26,132 is to be utilized by 3/31/2022. These funds will purchase equipment to enhance the community room. This will allow the Ocala Police Department to cater to those in the community who are visual learners and/or hearing impaired while facilitating community engagement efforts.

FINDINGS AND CONCLUSIONS:

Funding will be used to purchase visual production equipment.
