

BUDGET RESOLUTION 2022-116

A RESOLUTION AMENDING THE FISCAL YEAR 2021-2022 BUDGET TO APPROPRIATE FUNDS FOR THE CITY OF OCALA'S STATE HOUSING INITIATIVES PARTNERSHIP PROGRAM (SHIP) FUND IN THE AMOUNT OF \$274,524

WHEREAS, the 2021-2022 General Appropriations Act was signed into law on July 19, 2021, appropriating \$49,648,298 to the State Housing Initiatives Partnership Program (SHIP); and

WHEREAS, the City was appropriated \$410,929 in Fiscal Year 2021-2022 from the State Housing Initiatives Partnership (SHIP) Funding from the State of Florida to provide decent housing, create suitable living environments, and expand economic opportunities for low and moderate income persons; and

WHEREAS, \$136,405 was received by the City on July 28, 2021 and appropriated by City Council at the August 18, 2021 meeting by adopting budget resolution 2021-166; and

WHEREAS, on November 17, 2021 the City received the remaining SHIP funding in the amount of \$274,524 from the Florida Housing Coalition.

NOW THEREFORE, BE IT RESOLVED, BY THE CITY COUNCIL OF THE CITY OF OCALA, FLORIDA, duly assembled in regular session that the Fiscal Year 2021-2022 budget be amended as outline below to appropriate \$274,524 to carry out affordable housing activities as outlined in the City's Local Housing Assistance Plan (LHAP).
