# City of Ocala Community Development Block Grant (CDBG) Funds Proposed Substantial Amendment to the 2019-2023 Consolidated Plan and the 2018 and 2021 Annual Action Plan

### **Notice to Citizens:**

The City of Ocala receives Community Development Block Grant (CDBG) funds as an entitlement community. The U.S. Department of Housing and Urban Development (HUD) awards the City of Ocala Community Development Block Grant (CDBG) funds, to be used for the benefit of low/moderate income residents. Budgets and a summaries of program goals are detailed in Annual Action Plans prepared by the City for each relevant fiscal year. These plans prioritize needs and list specific objectives to accomplish activities identified in the 5-year Consolidated Plan.

The City encourages citizen participation in developing these plans as detailed in the Citizen Participation Plan. The plan also describes the process for amending the Consolidated Plan and Annual Action Plan (AAP) when necessary. Because the City is proposing substantial amendments, notice is hereby given to citizens.

The amendments stem from postponement of projects, and fund reallocation in various years. The City is no longer allocating CDBG funds to the Phase 1A Sidewalk Project. The City is increasing its CDBG Rehab Program funding amounts/allocations for the 2021 Program Year.

The following Amendments are proposed:

• Reallocate \$376,033 from Phase 1A Sidewalk Public Facilities Project in the 2018 Annual Action Plan to Housing Rehabilitation Projects in the 2021 Annual Action Plan
