

BUDGET RESOLUTION 2023-168

A RESOLUTION OF THE CITY OF OCALA, FLORIDA, ADOPTING THE FINAL BUDGET FOR DOWNTOWN DISTRICTS A, B, AND C FOR FISCAL YEAR 2023-2024 IN THE AMOUNT OF \$339,474
