## A RESOLUTION AMENDING THE FISCAL YEAR 2021 BUDGET TO ACCEPT AND APPROPRIATE FUNDING FOR THE CITY OF OCALA'S COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) PROGRAM IN THE AMOUNT OF \$455,013

WHEREAS, the 2020-2021 Community Development Block Grant (CDBG) adjusted agreement was received on December 17, 2020 approving the Fiscal Year 2020 CDBG Action Plan and awarding funding for the City's Fiscal Year 2021.

WHEREAS, the City was appropriated funding for fiscal year 2020-21 from the U.S. Department of Housing and Urban Development (HUD) to improve neighborhoods, provide decent housing and create new economic opportunities, with special focus on serving low-and moderate-income persons.

**WHEREAS**, the City was appropriated funds for fiscal year 2020-21 in the amount of \$455,013 from HUD for the CDBG program.

NOW THEREFORE, BE IT RESOLVED, BY THE CITY COUNCIL OF THE CITY OF OCALA, FLORIDA, duly assembled in regular session that the Fiscal Year 2021 Budget be amended as outlined below to appropriate \$455,013 to carry out activities as outlined in the City's CDBG Consolidated Plan.
