

BUDGET RESOLUTION 2020-106

A RESOLUTION AMENDING THE FISCAL YEAR 2019 BUDGET TO APPROPRIATE REIMBURSEMENTS RECEIVED RELATED TO HURRICANE IRMA IN THE AMOUNT TOTALING \$3,126,827

WHEREAS, on September 4, 2017, Governor Rick Scott issued Executive Order 17-235 declaring a state of emergency for every county in the State of Florida due to the severe threat posed by Hurricane Irma; and

WHEREAS, on September 5, 2017, President Donald Trump declared a pre-landfill emergency for the State of Florida to prepare for Hurricane Irma at the request of Governor Rick Scott; and

WHEREAS, on September 10, 2017, Hurricane Irma reached Marion County with tropical storm force wind and heavy rainfall; and

WHEREAS, the severity of the storm disrupted utilities and caused considerable property destruction within the City of Ocala; and

WHEREAS, the Office of Budget and Management has coordinated the reimbursement process with the Federal Emergency Management Agency; and

WHEREAS, the City has received reimbursements that should be appropriated into the FY2019 budget to replenish reserves used to support the initial recovery effort..

NOW THEREFORE, BE IT RESOLVED THAT THE CITY COUNCIL OF THE CITY OF OCALA, FLORIDA, duly assembled in regular session, that the FY2019 budget be amended as outlined below:
