

# BUDGET RESOLUTION 2020-126

## AMENDING THE FISCAL YEAR 2019 - 2020 BUDGET TO APPROPRIATE GRANT FUNDING FROM THE FLORIDA DEPARTMENT OF TRANSPORTATION IN THE AMOUNT OF \$121,118

**WHEREAS**, on May 19, 2015 the City Council entered into a long term lease with Sheltair Ocala, LLC, and Sheltair Ocala LLC agreed to commit \$2,000,000 to be used as grant match for City obligations in the design and construction of the General Aviation Terminal Building; and

**WHEREAS**, on June 2, 2015 the City Council adopted resolution 2015-66 authorizing entering into a Joint Participation Agreement (JPA) FM431586-1-94-01 with the Florida Department of Transportation (FDOT) for \$1,000,000; and

**WHEREAS**, on October 10, 2015 the City Council adopted resolution 2016-5 authorizing entering into Supplemental Joint Participation Agreement No.1 - FM431586-1-94-01 with FDOT for \$200,000; and

**WHEREAS**, on March 7, 2017 the City Council adopted resolution 2017-27 authorizing entering into Supplemental Joint Participation Agreement No. 2 - FM431586-1-94-01 with FDOT for \$1,300,000; and

**WHEREAS** on March 20, 2018 the City Council adopted resolution 2018-18 authorizing entering into Supplemental Joint Participation Agreement No. 3 - FM431586-1-94-01 with FDOT for \$732,559; and

**WHEREAS** on January 22, 2019 the City Council adopted resolution 2019-13 authorizing entering into Supplemental Joint Participation Agreement No. 4 - FM431586-1-94-01 with FDOT for \$330,825; and

**WHEREAS**, the Airport can support the additional cost share of \$121,118 by utilizing savings from direct purchases and transferring funds that were budgeted for office furniture and previously appropriated for the Airport car wash.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF OCALA, FLORIDA**, duly assembled in regular session that the FY 2019/2020 budget be amended to appropriate funding as outlined below:
